#### REPRESENTATIVE EXPERIENCE:

- Jackie Gregory prevailed at a merits hearing before the Judge of Compensation Claims. Claim was made for an extensive timeframe of Temporary Partial Disability Benefits, plus penalties, interest, costs and attorneys' fees. The JCC denied the benefits as well as entitlement to attorneys' fees and costs.
- Jackie prevailed on behalf of the Employer/Carrier at a Final Merits
  Hearing at which the issues litigated were permanent total disability
  benefits, supplemental benefits, attorneys' fees, costs, penalties and
  interest. All claims were summarily denied and dismissed by the Judge
